



MEMBERSHIP FEE:

The 2020 1/3 Membership fee is \$1,800. If fee is not paid in full at time of joining, the fee increases to \$1,900 with \$950 due the day of and remaining \$950 paid in full by April 15th. Otherwise, membership privileges will be suspended until member is in good standing. The Membership fee is non-refundable and non-transferable. Accepted forms of payment include Cash, Credit Card, or Personal Check.

MEMBERSHIP INCLUDES:

- Unlimited green fees on Course No. 1 and No. 3 (weekend play limitations)
- One weekend green fee before 11am on Course No. 1 or No. 3 (*cart fee not included)
- Three guest golf vouchers, good towards Course No. 1 or No. 3
- Ability to play Dubsdread and Course No. 2 for a reduced rate (*cart fee not included)
- 20% off all non-sale soft goods in golf shops
- Preferred rates for Cog Hill-run events
- Membership valid January 1st, 2019 - December 31st, 2019

MEMBERSHIP ADD ONS:

- Cart Fee- \$17 per regular round, \$11 per twilight round
- Weekday Golf on Dubsdread - \$117, fee includes cart.
- Weekday Golf on Course No. 2 – \$20, plus cart fee if riding
- CDGA Handicap - \$40

FACILITY RULES:

Cog Hill, being a public facility, requires members to adhere to the following:

1. Members must check-in at the golf shop prior to each round
2. Members cannot tee off prior to first scheduled tee time
3. Members must play holes in order and start on 1st tee for each round
4. Members cannot play multiple golf balls on each hole
5. Overnight club storage is not available on Cog Hill property

MEMBER CHARGES/BILLING:

1/3 Members are provided the opportunity to pay for merchandise, guest fees, food and beverage, etc. at the time of purchase or charge to their member account.

On the 1st of each month a statement will be sent to each Dubsdread Member. On the 15th of each month, members who have requested Cog Hill use their credit card on file will be charged, otherwise the member agrees to pay the account balance by this time. If payment is not received by the 30th of each month, Cog Hill will deem the account "delinquent" and charge the credit card provided and kept on-file. Member accounts will be reviewed and continued delinquency may be grounds for membership termination.

MEMBERSHIP TERMINATION:

Cog Hill reserves the right to suspend or terminate membership privileges or access to the facility, where applicable, due to overall conduct or account status. This applies to any member, at any time.
